This has reference to your application I.D. Nos. 5584-02-06-2021, 5590-04-06-2021 and 5693-15-06-2021 seek accreditation by National Board of Accreditation in Tier-I format to UG Engineering programs and PG Engineering program offered by National Institute of Technology Patna, Asok Raj Path, Patna – 800005, Bihar.

2. An Expert Team conducted online evaluation of the programs from 03rd to 05th December, 2021. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The UG- Electrical Engineering program has been granted accreditation for 3 years. National Institute of Technology Patna, Asok Raj Path, Patna – 800005, Bihar should submit the Compliance Report for these programmes at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.



The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to National Institute of Technology Patna, Asok Raj Path, Patna – 800005, Bihar as a whole. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
